- the meeting of the Management Board was held on which the Management Board, among others, decided on adopting the quarterly report for the fourth quarter of 2023 (unaudited, consolidated and non-consolidated) and the Annual Report and the annual financial statements of the Company for the year 2023 (audited, consolidated and non-consolidated), and proposal for the dividend payout in the amount of EUR 0,75 (in words: zero Euros and seventy-five cents) per share was adopted, and
- the meeting of the Supervisory Board was held on which the Supervisory Board, *inter alia*, decided on adopting the Annual Report and the annual financial statements of the Company for the year 2023 (audited, consolidated and non-consolidated) and proposal for the dividend payout in the amount of EUR 0,75 (in words: zero Euros and seventy-five cents) per each share was adopted.

Pursuant to the provisions of Articles 300.c and 300.d of the Companies Act, by the Supervisory Board's approval of the annual financial statements of the Company for the year 2023 (consolidated and non-consolidated), the annual financial statements of the Company for the year 2023 (consolidated and non-consolidated) are considered as approved by the Management Board and the Supervisory Board.

Annual report of the Company for 2023 shall be publicly announced on 29 February 2024. It shall be presented to interested financial analysts and media representatives at the conference to be held on 1 March 2024 at 11:00 CET, as previously announced.

As per the dividend payout proposal, the record date would be 6 May 2024, the ex date would be 3 May 2024 and the payment date would be 15 May 2024. The full text of the decision proposal for dividend payout will be announced in the invitation to the General Assembly, pursuant to relevant regulations.
