("the Company") hereby notifies that the investment company Interkapital vrijednosni papiri d.o.o. made the following acquisition of Company (treasury) shares, in the name and on behalf of the Company, at the regulated market of Zagreb Stock Exchange (ZSE), in line with the Treasury Share Buyback Program:

- On 17 November 2023, 120 shares, identification code ARNT, were acquired at a weighted average price of EUR 29.8833 per share, representing 0.0023% of the Company's issued share capital.

Following this acquisition, the Company holds in total 84,047 treasury shares, representing 1.638752% of the Company's issued share capital. Share capital amounts to EUR 13,613,965.00, and it is divided into 5,128,721 shares without nominal value.
