Pursuant to Article 474 of the Capital Market Act, Arena Hospitality Group d.d. ("the Company") hereby notifies that the investment company Interkapital vrijednosni papiri d.o.o. made the following acquisitions of Company (treasury) shares, in the name and on behalf of the Company, at the regulated market of Zagreb Stock Exchange (ZSE), in line with the Treasury Share Buyback Program:

- On 12 July 2019, 157 shares, identification code ARNT, were acquired at a weighted average price of HRK 378.00 per share, representing 0.003061 % of the Company's issued share capital.
- On 15 July 2019, 88 shares, identification code ARNT, were acquired at a weighted average price of HRK 376.00 per share, representing 0.001716 % of the Company's issued share capital.

Following these acquisitions, the Company holds in total 7,565 treasury shares, representing 0.147503 % of the Company's issued share capital. Share capital amounts to HRK 102,574,420.00, and it is divided into 5,128,721 shares without nominal value.
