Pursuant to Article 474 of the Capital Market Act, Arena Hospitality Group d.d. ("the Company") hereby notifies that:

- On 14 November 2019 the Company acquired 25,000 shares, identification code ARNT, at a price of HRK 372.00 per share, representing 0,004875 % of the Company's issued share capital.

The aforementioned Company's shares were acquired based on the General Assembly authorization decision dated 30 August 2017 and outside the Company's Treasury Share Buy-Back Program, i.e. by purchase of a part of the Company's shares which the Centre for Restructuring and Sale (CERP) offered for sale on the regulated market of Zagreb Stock Exchange (ZSE)

Following this acquisition, the Company holds in total 43,747 treasury shares, representing 0,008530 % of the Company's issued share capital. Share capital amounts to HRK 102,574,420.00, and it is divided into 5,128,721 shares without nominal value.
